THESE ARE ALL AIMED TO ENABLE SELF SUFFICIENCY THROUGH SHARPENED LIVING SKILLS IN THE WORK/LIFE BALANCE. 07. Significant program services not listed on prior year return (Part III, line 2)

The supplemental sanitation services that ACE conducts through Project Stay are being required to participate in the NY City 'Containerization' initiative. This requires ACE to purchase, insure, maintain and use NYC approved containers for refuse storage at the NY City neighborhoods serviced through ACE's sanitation services contracts. Part X of the 990, Other Assets includes a \$153,277 initial advance payment incurred by ACE for thirteen of the approved containers. There is \$1,000,000 total estimated required ACE outlay to meet the number of containers required by the City of New York for the present sanitation service contract obligations. The City of New York has advised ACE that they have allocated the \$1,000,000 for reimbursement of the containers.

08. Cessation of, or significant change to, any program services (Part III, line 3)

ACE revamped vocational programming in 2025 including the addition of job clubs organized by industry, new computer classes tiered by level and restructured class schedules resulting in expanded capacity for the literacy and numeracy classes. ACE also held it's first Career Fair bringing in employers from different industries together for the benefit of program participants, where some participants were able to secure employment. The intent here is to make this an annual event.

09. Explanation of other changes in net assets or fund balances (Part XI, line 9)

Form 990 part X column B line 28 - Net Assets with Donor Restrictions has two components. The first includes \$100,836 of a restricted conditional promise to give these funds to pay for a new sanitation vehicle to be used in Project Stay in 2025. Such vehicle was acquired and put into service in 2025, but the reimbursement from the City of New York remained outstanding as at December 31, 2025. The second component is comprised of \$215,435 of funds raised for a capital campaign. The capital campaign is a multi year fundraising effort to accumulate a goal of \$5 million to expand the ACE Project Comeback educational program.
